## ORDER

The Indian Plywood Industries Research & Training Institute (IPIRTI) was merged with the ICFRE-Institute of Wood Science and Technology (IWST), Bengaluru as per Ministry's order No.16-1/2022-RT dated 22.10.2022. Accordingly, 25 technical posts alongwith 20 incumbents were transferred to ICFRE-IWST, Bengaluru. To process the merger of technical staff, options were obtained from the 20 incumbents, seeking their choice of Recruitment Rules by which they would like to be governed. Out of 20 incumbents, 17 opted to be governed by "ICFRE-TSR-2013" and 03 opted to continue with the "IPIRTI Service Rules, 2015 for recruitment and assessment promotion of Technical and support staff". Based on the options exercised by the respective employees and posts held by them, the Director General, ICFRE, orders as follows:

- 2) The posts listed against the names of respective employees at Col.4 of Table-I be added in the ICFRE TSR 2013 against the Sanctioned Strength of ICFRE-IWST, Bengaluru.
- 3) Based on the options exercised by the individual employees, the respective employees are granted the designations of ICFRE-TSR-2013 as listed in Col.6 of Table-I.

4) The employees listed in Table – II have opted to be governed as per "IPIRTI Service Rules, 2015 for recruitment and assessment promotion of Technical and support staff".

5) The employee listed at Sl. No. 1 of Table II having since resigned after merger, the consequent vacant post be added in the ICFRE – TSR – 2013 as Technical Assistant – Category – II (Pay Level-5) in the Sanctioned Strength of ICFRE-IWST, Bengaluru as per Col.4 of Table-I.

6) The employees listed at Sl. No. 2 and 3 shall continue to be governed as per their options and their corresponding posts as at Col.3 shall presently be added to the sanctioned strength of ICFRE-IWST as Draughtsman Gr.-II (IPIRTI) and Mechanic (IPIRTI) in Pay Level-2 specifically mentioning their current post and pay level as indicated at Col.5 of Table – II. However, when these posts will be vacated by the incumbents due to superannuation / resignation or any other reason, then these posts i.e., Draughtsman Gr.-II (IPIRTI) and Mechanic (IPIRTI) shall be added into ICFRE-TSR-2013 as per the posts mentioned in Col.4 of Table-I.

7) The Table-III below enlists 7 posts which do not match with the framework of Direct Recruitment posts of ICFRE-TSR-2013 and therefore are required to be upgraded / downgraded for inclusion in ICFRE-TSR-2013. As this shall require approval of the Ministry, a proposal with regards to the same be moved.

8) It has been decided that these posts shall be temporarily added to the sanctioned strength of IWST with existing nomenclature (Col.3 of Table-III), and shall finally be appropriated against the posts in the ICFRE framework as may be directed by the Ministry. However, since the Incumbents of these posts have opted to be governed by ICFRE-TSR-2013, corresponding designations as shown against their names at Col.6 of the Table-III are hereby granted with their career progression to be regulated as per ICFRE-TSR-2013.
