#### 2. **DEFINITIONS**

- a) Assistant Director General (Admin), ICFRE, mentioned herein means the Deputy Director General (Administration), ICFRE Dehradun representing ICFRE; and his official successors, nominees as may be designated by ICFRE from time to time.
- b) EMD means Earnest Money Deposit
- c) PBG means Performance Bank Guarantee
- d) Firm means a duly registered Firm or Company registered under Indian Laws as such, and bidding for this tender.

#### 3. SCOPE OF WORK

a) The Indian Council of Forestry Research and Education (ICFRE) invites tenders from reputed Original Equipment Manufacturers (OEM) or their authorized agents/ dealers/ distributors/channel partners for Supply, Installation and Commissioning of the IT Hardware with buyback arrangement as per the Schedule-II-A TO Schedule-III-C and Schedule-III-A TO Schedule-III-C.

b) The supplier will replace all configurational assemblies, internal / external components such as Motherboard, RAM, Hard disk, CD/Combo/DVD Drive/Inlay Cards (Network, VGA, sound etc), Ports (COM, LPT, USB etc) Keyboard, Power adaptors, Laptop battery/ battery charger or any other existing component / card in any machine (Laptop/ Computer) on comprehensive basis found defective during the Warranty/Guarantee period.

c) Original Printed Product Literature pertaining to the quoted products must be

enclosed along with tender.

d) A proper undertaking for the after sale service being available at Dehra Dun must be submitted with the tender.

e) Validity of offer shall be 180 days from the last date of submission of bids.

- f) The stores are required to be delivered as per the supply order in full or part placed by the officials at ICFRE HQ, Dehradun within 30 (thirty) days, however the delivery date can be extended further at the discretion of the Assistant Director General (Administration), ICFRE. The official of ICFRE HQ may place supply order of quoted IT hardware (Computer and Laptop) as per specifications mentioned in Schedule II and Schedule III.
- g) The successful bidder shall furnish, before signing the Contract, a Performance Bank Guarantee issued by a Nationalised Bank in favour of Account Officer, ICFRE, Dehradun, having validity of sixty days beyond the date of expiry of the Contract, for an amount of 15,000/- (Rupees Fifteen Thousand only). The Performance Bank Guarantee as per the Form-IV must be submitted along with the letter of acceptance within the stipulated time.

h) The performance guarantee shall only be released after successful completion of

the warranty period of three years.

#### 4. GENERAL TERMS AND CONDITIONS

a) Bidders are advised to study the tender document carefully. Submission of bids shall be deemed to have been done after careful study and examination of the tender document with full understanding of its implications.

b) Any clarifications from ICFRE or any change in requirement shall be posted on <a href="https://eprocure.gov.in">www.icfre.gov.in</a> and <a href="https://eprocure.gov.in">https://eprocure.gov.in</a>. It shall be the sole responsibility of the bidder to check for any changes of aforementioned website before submitting the bids.

c) ICFRE shall not be responsible for non-receipt / non-delivery of the bid

documents due to any reason whatsoever.

- d) The bidder shall indicate the complete address of the Firm and work along with the name(s) of the contact person(s) and their telephone / Fax / Mobile Nos.(s) and other particulars as per Form-I.
- e) An EMD of Rs. 15,000/- (Rupees Fifteen Thousand only) in the form of Fixed Deposit Receipt or Bank Guarantee drawn on any nationalized bank in favour of Account Officer, ICFRE payable at Dehradun shall be deposited as a part of qualifying bid of the Tender. The EMD shall be returned to bidders upon finalization of the successful bidder and award of the contract. No interest shall be payable on the EMD by ICFRE. The EMD submitted by the bidder may be forfeited at any stage, if the bidder backs out of the bidding process after submitting the bids to ICFRE or fails to accept the work order issued to the firm.

- g) Acceptance of the bid shall be communicated to the successful bidder by a formal Letter of Intent (LoI).
- h) The bidders shall be allowed to inspect the existing Desktop/ Laptop as in Schedule-I of this tender document between 10:30 AM to 4:30 PM on all working days before the last date of submission of the tender. The firm shall raise a formal request for the purpose to Head, IT Division, ICFRE for ICFRE Head Qtrs. ICFRE shall not be responsible for any cost incurred on such inspections.
- ICFRE reserves the right to accept the tender in whole or in part.
- The ICFRE does not bind itself to accept the lowest quote or part thereof. ICFRE reserves the right to cancel any or all tenders received without assigning any reason thereof.
- k) All information submitted or supplied in the formats of this tender document shall be presumed to be true to the best of knowledge of the bidder.
- Short-listing of a bidders do not confer any rights on any bidder, it only means that the offer made is under consideration.
- m) No legal proceedings to enforce any claim and no suit arising out of this purchase contract shall be instituted except in a court of competent jurisdiction over Dehradun, Uttarakhand.
- n) The successful bidder shall furnish, before signing the Contract, a Performance Guarantee issued by a Nationalised Bank in favour of Account Officer, ICFRE, Dehradun, having validity of sixty days beyond the date of expiry of the Contract, for an amount of Rs 15,000/- (Rupees Fifteen Thousand only). Performance Bank Guarantee as per the Form-IV must be submitted along with the letter of acceptance within the stipulated time.
- o) EMD is liable to be forfeited if wrong information is furnished as regards to the qualifying, technical and financial proposals.
- p) The Assistant Director General (Admin) ICFRE, Dehradun, reserves the right without assigning any reasons thereof, to:
  - i. Modify or alter any or whole of the quantity as well as specifications of the IT hardware.
  - ii. Accept or reject whole or any part of an offer.
  - iii. Reject any or all offers partly or wholly.

- q) Conditional tenders are liable to be rejected.
- r) Within forty five days of issue of Letter of Intent (LoI) the successful bidder shall
  - Sign a contract with ICFRE for 'Supply and installation of IT Hardware with buyback', on a stamp paper of Rs. 100/- to be furnished by the firm.
  - Furnish a Performance Bank Guarantee issued by a Nationalised Bank in favour of Account Officer, ICFRE, Dehradun, having validity of sixty days beyond the date of expiry of the Contract, for an amount equivalent of Rs 15,000/- (Rupees Fifteen Thousand only).

### 5. BUYBACK OF EXISTING IT HARDWARE

a) The bidders are required to quote for buy-back of IT Hardware (Computer and Laptop etc) on "as is where is" as per detailed at Schedule-I.

b) The existing Computers, Laptop are to be collected by the supplier at its own cost from the location wherein new Computers, Laptop will be installed with proper acknowledgement.

### 6. WARRANTY/SUPPORT

a) The equipment supplied will be warranted against bad workmanship and manufacturing defects, as mentioned in Bill of Material, from the date of acceptance of the system whole. Service support for the entire warranty period will be on site and comprehensive (including spares and all software support) for the entire warranty period. The warranty must be certified by OEM. The defects, if any, shall be attended to on immediate basis but in no case any defect should prolong for more than five working days.

b) Any replacement or repair required within the warranty period shall be provided by the supplier free of cost. No traveling allowances or transportation costs or any other cost will be paid by the purchaser during warranty period on

account of maintenance.

c) Any claim arising under this warranty period will be notified to the supplier through Email/Telephone/Fax and upon receipt of such notice; the supplier will repair/replace the defective goods or any part thereof without cost with immediate effect.

### 7. DELIVERY/INSPECTION AND INSTALLATION and RECEIPT OF EXISTING Laptop/Computer

a) The supplier shall deliver and install Computer, Laptop at ICFRE Head Qtr, Dehradun within 1 (one) month whenever any Letter of Intent (LoI)/ Purchase The HQ, Dehradun. official of ICFRE issued by Computer/Laptop is also to be collected under buyback from the same location

b) Delivery Certificate, Installation Certificate of new Computer / Laptop and receipt of existing Computer / Laptop should be submitted along with the bills at Information Technology Division, ICFRE Head Qtr, Dehradun.

#### 8. THE CONTRACT

- a) The contract shall not be assigned or sublet in whole or in part by the firm without prior written consent of Assistant Director General (Admin), ICFRE. Any assignment or subletting of this contract by the firm or any interest therein, or of any money due or to become due by reason of the terms hereof, shall be null and void without prior written consent of Assistant Director General (Admin), ICFRE having been obtained.
- b) This contract shall not be deemed an asset of the firm in any form.
- c) If the vendor violates any of these terms and conditions, the PBG shall be liable for forfeiture, wholly or partly, as decided by Assistant Director General (Admin), ICFRE and the contract may be cancelled.
- d) No legal proceedings to enforce any claim and no suite arising out of this contract shall be instituted except in a court of competent jurisdiction over Dehradun, Uttarakhand.
- e) No variation in or modification of the terms of the contract shall be made except by written amendment signed by both the parties i.e. the successful bidder and the Assistant Director General (Admin), ICFRE.

#### 9. PENALTYFOR FAILURE TO MAINTAIN DURING THE WARRANTY PERIOD

a) If the supplier fails to attend the complaints/fails to rectify the defects within five working days after logging of complaints during the warranty period, remedial action shall be taken such as forfeiture of security deposit by the supplier in the form of Bank Guarantee.

#### 10. PAYMENT TERMS

- (i) 100% payment shall be made after delivery, successful installation and commissioning against the supply order subject to submission of Security Deposit in the Performance Bank Guarantee.
- (ii) The payment is subject to TDS as per Income Tax Rules / Laws. The ICFRE shall deduct such taxes, duties and any other statutory levies imposed by the Government on such charges as may arise from the implementation of the contract agreement.
- (iii) No claim on account of sales tax, service tax, VAT, work contract tax or any other taxes and duties presently in force for the material used for execution of the work awarded under the contract, will be entertained and all such taxes and duties shall be borne by the firm.
- (iv) The violation of any of these terms and conditions mentioned in the Tender Document, the whole or part of Performance Bank Guarantee shall be liable for forfeiture, as decided by the Assistant Director General (Admin), ICFRE. Such decisions shall be the binding on the firm

#### 11. ARBITRATION

Except where otherwise provided in the contract all questions and disputes whatsoever in any way arising out of or relating to the contract or otherwise concerning the work or the execution or failure to execute the same whether arising during the progress of the Maintenance Contract or after the completion or abandonment thereof shall be referred to the sole arbitration of the person appointed by the Director General, Indian Council of Forestry Research & Education, (DG, ICFRE) Dehradun on his behalf at the time of dispute. There shall be no objection to any such appointment that the arbitrator so appointed is an employee of ICFRE, or government servant or that he/she had to deal with the matters to which the contract relates or that in the course of his/her duties as an employee of ICFRE, or government servant, he had expressed views on all or any of the matters in dispute of differences. The arbitrator to whom the matter is originally referred being transferred or vacating his/her office or being unable to act for any reason, shall be replaced by another person as decided by DG, ICFRE, to act as arbitrator in accordance with the terms of the contract. Such person shall be entitled to proceed with the reference from the stage at which it was left by his/her predecessor. It is also a term of this contract that no person other than a person appointed by the Director General, ICFRE should act as arbitrator and if for any reason, that is not possible, the matter is not to be referred to arbitration

Subject as aforesaid, the provisions of the Arbitration and Conciliation Act 1996 or any statutory modifications or re-enactment thereof and the rules made there under and for the time being in force shall apply to the arbitration proceeding under this clause.

Services under the contract shall, notwithstanding the existence of any such dispute, question or controversy, continue during arbitration proceedings and no payment, due or payable by ICFRE or the firm shall be withheld on account of such proceedings unless such payments are the direct subject of the arbitration. Reference to arbitration shall be a condition precedent to any other action at law.

#### 12. FORCE MAJEURE

- i) The performance of the obligations of either party under this Agreement is subject to Force Majeure.
- ii) If a Force Majeure situation arises, either party shall promptly notify to the other party in writing of such conditions and the cause thereof. Unless otherwise directed by ICFRE in writing, the vendor shall continue to perform its obligations under this agreement, as far as it is reasonably practical. Either party reserves the right to terminate this contract, without any additional liabilities to either party, if the Force Majeure period continues for more than 180 (One hundred and eighty days).

#### 13. PREPARATION AND SUBMISSION OF PROPOSAL

ii) The proposal should not have any interlineations or overwriting except as necessary to correct errors made by the concerned themselves, in which cases such corrections must be initialed by the person or persons authorised to sign the proposal. In case of violation of this condition, the bid shall be rejected and no communication shall be entertained in this matter.

#### 14. PROPOSAL EVALUATION
