TENDER DOCUMENT FOR PRODUCTION OF SHORT DOCUMENTARY FILM AND AUDIO VISUAL ON "COLD DESERT: NORTH WESTERN HIMALAYA"

Himalayan Forest Research institute (HFRI), Shimla intends to produce/prepare a Documentary film on "Cold Desert of Western Himalaya" to promote Forestry Research activities in Cold Desert.

For production/preparation of a documentary film (20-25 minutes) on cold desert of NW Himalaya. Intending **Film Production/Preparation Company/Firm /Agency** are invited to submit the bids for the subject cited above subjected to fulfilling the following criteria:

Eligibility Criteria

- a) The **Company/firm /Agency** should have been in existence for a minimum of Three years. Proof of them same to be submitted along with the technical bid.
- b). The Company should have experience of making at least Two short films/ Documentary film of either State or National or International standard. Work Order and Completion Certificate of the work needs to be submitted. SELF DECLARATION MUST BE SUBMITED in organization/ firm/Agency's letterhead.
- c) The Company should have a well-trained in-house production team. List of in-house production team stating their Designation and Experiences in relevant field should be submitted with Technical Bid and their CVs duly signed by the employee.
- d) Copies of Articles of Association (in case of registered firm). Bye laws and certificate of registration (in case of registered cooperative societies). Partnership deed (in case of partnership firm) should be submitted along with the technical bid.
- e) The bidder must submit a self-certificate in court affidavit that it has not been blacklisted by any Govt. department/ agency since its inception.
- f) Valid GST number and supporting document submitted along with the technical bid

The bidder must ensure that the documentary proofs to substantiate clauses (a) to (f) above are given in their technical bid otherwise the bid shall not be considered for evaluation.

(A) Scope of Work

- a) The duration of full version of documentary film is to be of 20-25 minutes and 5-8 minute of short version film.
- b) One minute's promotional video will also to be submitted.
- c) Master production of HD format.
- d) The film shall contain success stories attached as (Annexure-I)
- e) It should be a well written concept around which the entire film would be based.
- f) The voice over shall be in Hindi & English languages.
- g) Shooting must be done by high end HD camera/Drone Camera.
- h) The project must be completed within 45 days from the release of work order.

(B) The work/ cost include:

- a) Script & Research (Pre-production)
- b) Production
- c) Raw stock
- d) Fooding & lodging
- e) Transportation
- f) Post-Production

- g) Remuneration
- h) Delivery in the format: DVDs (HD) & Pen drives

(C) Submission of Tender Fee

a) The non-refundable tender fees of **(Rs 1180 only inclusive of GST)** must be submitted in the form of Demand-Draft drawn on a scheduled bank in favor of **"Director, HFRI Shimla"** payable at Shimla may be placed in an envelope. The envelope should be sealed and superscripted "Tender fee for production of **SHORT DOCUMENTARY FILM on Cold Desert of western Hiamlaya"**. The envelope should be addressed and submitted to Director, Himalyan Forest Research Institute, Conifer Campus, Panthaghati, Shimla, HP 171013 before the due date and time specified in this document.

- Supply order/work order would be awarded only after complete satisfaction of the Director, HFRI, Shimla-171013
- The firm shall submit bill for the work done by him for the payment after completion of the work within stipulated time given in the work order.
- The tender will be bound by the HFRI/ ICFRE rules and regulations
- Income tax will be deducted at source as per Income Tax Act and the TDS certificate to this effect shall be issued to the contractor by the HFRI.
- Performance Security Money @ 5% of the quoted price will be deposited, on the receipt of Supply order in the shape of demand draft.
- In the event of non-completion of the works within stipulated period the Performance Security will be forfeited as under:
 - a. For delay up to 10 days the Performance Security will be forfeited @ 25%.
 - b. For delay up to 10-20 days the Performance Security will be forfeited @ 50%.
 - c. For delay up to 20-30 days entire Performance Security will be forfeited.
 - d. After 30 days supply order will be cancelled.
