3. SCOPE OF WORK FOR THE FIRM

- b) The firm shall implement network policies in liaison with the IT Division, ICFRE HQ to meet the requirements of latest ICT (Information and communications technologies) for a robust Local Area Network (LAN) services across ICFRE.
- c) Maintenance Contract will be comprehensive includes preventive maintenance / regular services of the LAN nodes (networking) and LAN switches conduit pipes, optical fiber cables including accessories / or replacement of all such hardware / item necessary for keeping them in perfect working order and condition at all the times during the contract period from any defects/ disturbances or any unscheduled call for corrective and maintenances services requires for full functioning.
- d) The replacement of all spares of hardware which develop defects / suffer breakdown during the period of Maintenance Contract, is included under the comprehensive Maintenance Contract. Defective parts will be replaced with same make spares or better quality/configuration. In case of non-availability of the existing or hardware/items to be replaced with branded hardware / item without any extra charges. These replaced parts shall be the property of ICFRE soon after installation. Released components after replacement would be firm's property.
- e) Interchanging of data communication equipment from one location to other location shall be done when and where the situation demands for developmental as well as restoration of network with the approval of Incharge IT Division at respective locations of ICFRE.
- f) The firm has to do the media access control address (MAC address) binding of I/O ports of connected devices at ICFRE Head Qtr and its Institutes/Centres. The punching and replacement of I/O boxes to be done by the firm whenever necessary.
- g) The firm has to replace the defective I/O Boxes, if any, punching of the same, cable labelling and rationalization by reordering the messy cabling, if any, at any locations as given in **Schedule VII**.
- h) The firm shall provide support for configuration of switches, network equipment and its software licenses (if any), and existing LAN hardware as and when needed by ICFRE (HQ) and its Institutes/ Centres.

- m) The firm shall post qualified and certified resident Service Engineers / Technical Support on call basis, as per the detailed requirements given in Schedule VII-A.
- n) As part of Maintenance Contract, the Resident Service Engineer shall carry out quarterly preventive maintenance, with prior appointment with the authorized representative of the respective location listed in Schedule VII.
- o) The replacement of the components shall be done in the premises at all the locations given in Schedule VII, including ICFRE HQ at Dehradun. In case of any offsite service requirements of equipment(s), prior written permission from the authorised representative of the respective location shall be mandatory.
- p) The firm shall keep fairly good stock of components at the site with the resident engineers so as to minimise the downtime of machines/equipments.

- t) The firm shall submit monthly maintenance report to the authorized representative of respective locations. The firm shall arrange the requisite documentation and maintain necessary records, including photos of the rack etc. The firm shall ensure the communication of quarterly preventive maintenance reports duly signed and stamped by the Nodal Officer of respective institute to IT Division, ICFRE HQ for processing the quarterly payment during the period of Maintenance Contract. In the event of non receipt of such quarterly preventive maintenance reports, the quarterly payment shall not be processed. - u) The ICFRE reserves the right to change the location of equipments. It shall be the responsibility of the firm to provide the services at the changed location as per prescribed rates. The list of equipment under the contract shall be modified accordingly.
- v) The firm shall provide / keep up the network connectivity till the each user end through I/O Box Cat 5 or otherwise across ICFRE locations given in **Schedule VII-A.**
- w) All repairs and service of equipments shall be carried out on site and in exceptional circumstances the equipment/component is/are to be taken to the company premises/service centre for repair then standby component shall be provided / installed forthwith till rectification of complaint/re-installation of the same.
- x) The equipment being taken to the service centre for repair would be at firm own risk and expenses. ICFRE will not be liable for any carriage/travelling expenses.
- y) The replacement of components or equipment shall be in consultation and after approval of the ICFRE under orders/guidelines of respective Incharge, IT Division of ICFRE HQ/ Institutes / Centres.
- z) The firm shall maintain and use genuine/OEM components for replacement wherever needed and the firm shall not use sub-standard/duplicate component in any condition.

4. PERIOD OF MAINTENANCE CONTRACT

- a) Initially the contract shall be for <u>five years</u> subject to satisfactory fulfillment of the obligations laid down in the terms and conditions and contract of the tender document. The contract may be extended for the period of two years if the services are found satisfactory.
- b) The date of initiation of the contract will be the date of signing of the contract.

PERFORMANCE SECURITY

a) To ensure due performance of the contract, Performance Security in the form of Performance Bank Guarantee (PBG) from a Nationalised Bank, needs to be submitted by the successful bidder. The successful bidder shall have to submit a PBG of 3% of the

total contract value. The PBG should be valid for a period of six months beyond the contractual obligations. In case, the contract is extended for further two years, the bidder will extend the validity of PBG before its expiry. The PBG shall be submitted in the format given in **Schedule V**.

- b) The non adherence to the terms and conditions given herein and in subsequent Memorandum of Agreement with the successful bidder shall amount to breach of contract and may lead to forfeiture of Performance Security amount in full or in part.
- c) The firm shall carry out the services in conformity with general professionally and technically accepted norms relevant to such assignments that are required for the project and which are to the entire satisfaction of ICFRE.

Not withstanding this marking, the ICFRE reserves the right to change the equipment on account of failure or developmental purpose etc. without assigning any reason and the same can be included / excluded from the contract.
- I) The bidder shall indicate the location wise complete address of the Firm and Service Centre along with the name(s) of the contact person(s) and their telephone / Fax / Mobile Nos.(s) and other particulars as per the Performa at Schedule VIII. Further the bidder should have at least one service centre in Eastern India, West India, North India, South India and Central India.
- m) Commencement of Assignment shall be as per the Memorandum of Agreement (Contract) formalized with the successful firm.
- n) The Vendor shall maintain and use genuine/OEM components for replacement wherever needed and the vendor shall not use sub-standard/duplicate components under any circumstances. The replacement of equipment may be with same OEM or in case it is not possible to replace with same OEM, then with OEM which has maximum number of switch/LAN equipment.
- The Vendor shall abide by the applicable statutory provisions on minimum wages, payment of wages, EPF to the deputed Resident Engineers.
- p) The Vendor shall be responsible for deposit of the statutory dues under the EPF Act, 1952, ESI Act, 1948 for all Resident Engineers deputed at locations as per Schedule VII-A and ICFRE shall have no liability in this regard.
- q) The Vendor shall maintain all statutory registers under the Law and shall produce the same, on demand, to the authority of ICFRE or any other authority under the Law.

7. THE CONTRACT

- The General Terms and Conditions and the Service Level Agreement (SLA) shall form the part of the contract.
- b) If any part of the contract does not correspond or agree with any other part, or if any question arises as to the meaning of the terms of the contract or as to the performance of the work, ADG (Admin), ICFRE shall determine the matter and his/her decision shall be final and binding upon the parties to the contract.
- c) The contract when executed by the parties hereto shall constitute the entire contract between the parties in connection with the works covered, and shall be binding upon the parties hereto or upon either of them unless the said modification shall be in writing and duly executed by ICFRE and the firm.

- ii) The firm shall ensure the communication of Preventive Maintenance Reports / Service Call Reports of the network hardware/software in respect of the equipment under contract on quarterly basis signed and stamped by the respective Nodal Officers of the Institutes.
- iii) Payment shall be released after scrutiny of these reports and the amount for penalty for unsatisfactory maintenance or violations of contract conditions, if any, shall be deducted which shall be binding on the firm. The records maintained by the firm may be called for the purpose of scrutiny of the bills.
- iv) The taxes should be indicated separately in the bid and will be payable as per the Government Law. Any change in government taxation policy will be applicable.
- v) The ICFRE shall deduct such taxes, duties and any other statutory levies imposed by the Government on such charges as may arise from the implementation of the contract agreement.





IFGTB NETWORK TOPOLOGY


