Terms and conditions:

- The upper age limit for JRF/JPF is 28 years as on 1st June 2019 (Relaxable upto 5 years for SC/ST/Women/Physically Handicapped and OBC candidates)
- Candidates should submit their bio-data in person while attending the interview from 9.30 AM to 10.30 AM on 25-07-2019. The registration process will be closed by the above specified time on the date of walk-in-interview.
- The position is purely temporary and co-terminus with the project.
- 4. If at any time, in the opinion of the Director of the Institute you are found neglectful or unable to carry out research or guilty of conduct unbecoming of fellowship holder, the Director shall have the power to terminate your fellowship at any time without notice.
- The position can also be terminated at any time by the Director without assigning any reason or earlier depending on the performance of the candidates.
- Recruitment for the above temporary positions is governed by Rules for Junior/Senior Research Fellowship and Research Associateships-2018 of the Indian Council of Forestry Research and Education and does not guarantee subsequent employment in any Institutes under the Council.
- If the candidate has already worked as JRF/JPF for two years elsewhere, the total period of JRF/JPF + SRF/SPF shall not exceed four years. An applicant who has held a (CSIR/ICAR/UGC or any other fellowship for full tenure earlier is not eligible for fresh award of the same or lower category of fellowship.
- Candidates should bring their original testimonials of date of birth, educational qualification and community certificate for verification. Attested copies of the same are to be attached with bio-data form while appearing for the interview. Candidates without Provisional Certificate/Degree Certificate awarded by the Universities will not be permitted to attend the interview.
- 9. The number of posts of JRF/JPF may be changed as per the discretion of the Director.
- 10. Canvassing in any form will disqualify the candidate.
