2. Qualification:

- A. For Members of Indian Forest Service
- A.1 Essential Qualifications

A serving member of Indian Forest Service having completed 26 years of service with reference to year of allotment, who has at least 5 years research experience on posts in Forestry Research. The time spent in obtaining Ph. D. degree shall not be counted towards this minimum required research experience, unless the officer has held charge of a regular post in Forestry Research concurrently.

 - 1. Doctoral Degree

OR

- B. For Scientists
- B.1 Essential Qualifications

A candidate having First Class Master Degree in Basic Sciences/Agriculture & Allied Sciences/Forestry & Allied Sciences and other related disciplines from a recognized University, with 26 years of service with reference to the date of appointment as Group 'A' Scientist, and who has 15 years experience in Forestry Research. The time spent in obtaining Ph.D. degree small not be counted towards this minimum required experience, unless the Scientist has held charge of a regular post in Forestry Research concurrently.

- B.2 Desirable Qualifications
 - 1. Doctoral Degree

- 2. Head Quarters: The Head quarter of the Director, Institute of Forest Genetics & Tree Breeding shall be Coimbatore. The Director General, ICFRE, with the approval of the MoEF&CC can transfer the incumbent from one post to other, as and when circumstances, so warrant. However, the officer appointed would be liable to serve anywhere in India.
- 3. Age: Not exceeding 57 years as on 30.09.2019.
- 4. Eligibility: The crucial date for determining eligibility criteria shall be 30.09.2019.
- 5. **Tenure:** The tenure of deputation shall ordinarily be five years or till superannuation, whichever is earlier, and as per guidelines of the Government of India.
- 6. "Cooling off" requirement: "Cooling off", period for the post shall be as per guidelines of the Government of India.
- 7. **Debarment**: In case an officer, to whom offer of appointment to any of the above posts does not report either on his own volition or at the instance of the Cadre authority, he would be debarred from consideration for a post in ICFRE for a period of 5 years.
