**TENURE:** The tenure shall ordinarily be 5 years. The tenure, is however, liable to be terminable at an earlier date or extendable at the discretion of Director, IFGTB, Coimbatore.

**AGE LIMIT:** The upper age limit to apply for the above posts is 50 only as on closing date.
