Candidate should have valid certification with authorization number in the area of expertise mentioned above as per IT industry standard.

Essential Experience for Respective Qualification:

- Graduate should have 7 years of experience in Linux Server Environment with experience in management of UTM preferably in Data Centre Environment.
- Polytechnic Diploma Holder should have 8 years of experience in Linux Server Environment with experience in management of UTM preferably in Data Centre Environment.
