A candidate having First Class Master Degree in Basic Sciences/Agriculture & Allied Sciences/Forestry & Allied Sciences from a recognized University, with 26 years of service with reference to the date of appointment as Group 'A' Scientist, and who has 15 years experience in Forestry Research/Extension or Education. The time spent in obtaining Ph.D. degree shall not be counted towards this minimum required experience, unless the Scientist has held charge of a regular post in required field concurrently.

A.2 Desirable Qualifications:

- 1. Doctoral Degree
- 2. Teaching experience in Forestry discipline

(II) For the post of Director, Arid Forest Research Institute, Jodhpur

A. For Members of Indian Forest Service:

A.1 Essential Qualifications:

A serving member of Indian Forest Service having completed 26 years of service with reference to year of allotment, who has at least 5 years research experience on posts in Forestry Research. The time spent in obtaining Ph.D. degree shall not be counted towards this minimum required research experience, unless the officer has held charge of a regular post in Forestry Research concurrently

A.2 Desirable Qualifications:

1. Doctoral Degree

OR

B. For Scientists:

A.1 Essential Qualifications:

A candidate having First Class Master Degree in Basic Sciences/Agriculture & Allied Sciences/Forestry & Allied Sciences and other related disciplines from a recognized University, with 26 years of service with reference to the date of appointment as Group 'A' Scientist, and who has 15 years experience in Forestry Research. The time spent in obtaining Ph.D. degree shall not be counted towards this minimum required research experience, unless the Scientist has held charge of a regular post in Forestry Research concurrently.

A.2 Desirable Qualifications:

1. Doctoral Degree

(III) For the post of Director (International Cooperation), ICFRE, Dehra Dun:

The post is exclusively earmarked for appointment of Indian Forest Service (IFS) officers on deputation in ICFRE Hqrs., as duties require coordination with the State Forest Departments.

The eligibility criteria and other terms and conditions for the above said post are indicated below:-

A.1 Essential Qualifications:

A serving member of Indian Forest Service having completed 19 years of service with reference to year of allotment, who has worked for at least 3 years on the posts in Forestry Research. The time spent in obtaining Ph. D. degree shall not be counted towards this minimum required research experience, unless the officer has held charge of a regular post in Forestry Research concurrently.

A.2 Desirable Qualifications:

1. Doctoral Degree

Head Quarters:- The Head quarter of the Deputy Director General (Education) and Director (IC), shall be Dehra Dun. The Head quarter of the Director, Arid Forest Research Institute shall be Jodhpur. The Director General, ICFRE, with the approval of the MoEF&CC, shall transfer the incumbent from one post to other, as and when circumstances, so warrant. However, the officer appointed would be liable to serve anywhere in India.

Age:-Not exceeding 57 years as on 14.08.2018.

Eligibility:-The crucial date for determining eligibility criteria shall be 14.08.2018.

Tenure: The tenure of deputation shall ordinarily be five years or till superannuation, whichever is earlier, and as per guidelines of the Government of India.

"Cooling off" requirement:- "Cooling off", period for the posts shall be as per guidelines of the Government of India.

Debarment:- In case an officer, to whom offer of appointment to the above post does not report either on his own volition or at the instance of the Cadre authority, he would be debarred from consideration for a post in ICFRE for a period of 5 years.

General Instructions:

1. 3. Separate application should be submitted along with Demand Draft of Rs.200/- for each post if a candidate wishes to apply for more than one post.

7. The IFS officers who have not completed the mandatory "Cooling off" period, as the case may be, in his/her parent cadre between two spells of deputation as on 14.08.2018 will

not be considered for the post.

8. The Council reserves the right to relax, the qualifications/experience in case of exceptionally qualified and meritorious candidates.

9. The Council reserves the right not to fill up the vacancy advertised if the circumstances

so warrant in the interest of the Council.
