The time spent in obtaining Ph.D. degree shall not be counted towards this minimum required research experience, unless the Scientist has held charge of a regular post in Forestry Research concurrently.

B.2 Desirable Qualifications:

Head Quarters:-

1) The Head quarter(s) of Director, IFP shall be Ranchi

The Director General, ICFRE, with the approval of the Ministry of Environment, Forests and Climate Change can transfer incumbent working on the post of DDG/Director in the Council to another post of DDG/Director as per requirement and the officers appointed to these posts shall be liable to serve anywhere in India.
