The eligibility criteria and other terms and conditions for the above said post is stated below:

#### For Members of Indian Forest Service: A.

#### **Essential Qualifications: A.1**

A serving member of Indian Forest Service having completed 26 years of service with reference to year of allotment.

#### Desirable Qualifications: A.2.

- 1. Doctorate degree
- Expérience in Forestry Education and Extension 2.
- Teaching experience in Forestry discipline. 3.

#### Essential qualifications: **B.1**

candidate having First Class, Masters Sciences/Agriculture & Allied Sciences from a recognized University with Degree 26 years of service with reference to the date of appointment as Group 'A' Scientist, and who has 15 years experience in Forestry Research/Extension or Education. The time spent in obtaining Ph.D. degree shall not be counted towards this minimum required experience, unless the Scientist has held charge of a regular post in required fields concurrently.

#### B.2 Desirable Qualifications:

- Doctoral Degree. 1.
- Teaching experience in Forestry discipline. 2.

#### **HEAD QUARTERS**

The Head quarter of the Deputy Director General (Education) shall be Dehra Dun. The Director General, ICFRE, with the approval of the MoEF&CC can transfer the incumbent from one post to other, as and when such circumstances so warrant. However, the officer appointed to the post would be liable to serve anywhere in India.

#### **AGE**

Not exceeding 57 years as on 30.01.2024

#### ELIGIBILITY

The crucial date for determining eligibility criteria shall be 30.01.2024.

#### **TENURE**

The tenure of deputation shall ordinarily be five years or till superannuation, whichever is earlier, and as per guidelines of the Government of India.

### "COOLING OFF" REQUIREMENT

"Cooling off", period for the posts shall be as per guidelines of the Government of India.

#### **DEBARMENT**

In case an officer, to whom offer of appointment to the above posts does not report either on his own volition or at the instance of the Cadre authority, he would be debarred from consideration for a post in ICFRE for a period of 5 years.

### **GENERAL INSTRUCTIONS**

- 1. Application with complete bio-data together with a fee of Rs. 500/-(Rupees Five hundred only) in the form of Demand Draft drawn in favour of the Accounts Officer, ICFRE should reach the office of the Secretary, Indian Council of Forestry Research and Education, P.O. New Forest, Dehradun on or before 30.01.2024 in general and by 15.02.2024 in case of candidates residing in Andaman & Nicobar Island and Lakshadweep.
- 2. Application and the envelope should be superscripted as "Application for the post of Deputy Director General (Education) against Advertisement No. /DDG(Edu)/2023-ICFRE". Applications incomplete in any respect shall be summarily rejected.
- 3. In no case the Council will be responsible for non-receipt of application or any delay in receipt thereof on any account whatsoever. No application received after the stipulated last date will be entertained under any circumstances and all the late applications will be summarily rejected.
- 4. The candidate must submit their application through proper channel. The concerned department/organization should enclose vigilance clearance report and Annual Confidential Reports of the officer for the last seven

years for the years 2016-17 to 2022-2023 while forwarding the applications of the candidates. However, an advance copy can be submitted along with the prescribed fee.

- 5. The IFS officers who have not completed the mandatory "Cooling off" period, as the case may be, in his/her parent cadre between two spells of deputation as on 30.01.2024 will not be considered for the post.
- 6. The Council reserves the right to relax, the qualifications/experience in case of exceptionally qualified and meritorious candidates.
- 7. The Council reserves the right not to fill up the vacancy advertised if the circumstances so warrant in the interest of the Council.
